

The Ravenna Township Trustees met in Special Session Monday, September 12, 2011 in the Fiscal Office located at 6115 S. Spring Street, Door C. The meeting was called to order at 10:20 a.m. with the following present: Trustees, Gibson & Coia, Artz was absent; Becky Carter filling in for taking minutes and Jim DiPaola.

OLD BUSINESS:

Trustees discussed the Twyla Scott property located at 6286 Hill Street with a tax value of \$12,900.00. The Board has an offer of \$7,000.00 for it. Discussion on the property ensued.

Motion by Trustee Gibson, seconded by Trustee Coia to set a \$10,000.00 value for the property mentioned above. Roll Call: Mr. Gibson, yes; Mr. Coia, yes; Mrs. Artz, absent. Motion Passed.

Discussion on the Prospect Street property with no decisions made.

Trustee Gibson so moved, Trustee Coia seconded “to determine the cost and lot owner assessments for Forrest Ridge Lighting District, Phases 3 & 4 for the tax years of 2011, 2012, 2013, 2014, and 2015. The cost estimates were received by First Energy. All years’ total is \$661.75 and \$16.14 each for the tax payers per year. Roll call: Mr. Gibson, yes; Mr. Coia, yes; Mrs. Artz, absent. Motion Passed.

Trustee Gibson so moved, Trustee Coia seconded “to determine the cost and lot owner assessments for Forrest Ridge Lighting District, Phases 1 & 2 for the tax years of 2011, 2012, 2013, 2014, and 2015. The cost estimates were received by First Energy. All years’ total is \$992.63 and \$14.60 each for the tax payers per year. Roll call: Mr. Gibson, yes; Mr. Coia, yes; Mrs. Artz, absent. Motion Passed.

Trustee Coia so moved, Trustee Gibson seconded “to determine the cost and lot owner assessments for Pine Ridge Estates Lighting District, for the tax years of 2011, 2012, 2013, 2014, and 2015. The cost estimates were received by First Energy. All years’ total is \$378.14 and \$13.50 each for the tax payers per year. Roll call: Mr. Gibson, yes; Mr. Coia, yes; Mrs. Artz, absent. Motion Passed.

Trustee Coia so moved, Trustee Gibson seconded “to determine the cost and lot owner assessments for Portage County Metropolitan Housing Lighting District, for the tax years of 2011, 2012, 2013, 2014, and 2015. The cost estimates were received by First Energy. All years’ total is \$94.54 and \$94.54 each for the tax payers per year. Roll call: Mr. Gibson, yes; Mr. Coia, yes; Mrs. Artz, absent. Motion Passed.

Trustee Coia so moved, Trustee Gibson seconded “to determine the cost and lot owner assessments for the Reserves of Breakneck Creek Lighting District, for the tax years of 2011, 2012, 2013, 2014, and 2015. The cost estimates were received by First Energy. All years’ total is \$567.22 and \$12.60 each for the tax payers per year. Roll call: Mr. Gibson, yes; Mr. Coia, yes; Mrs. Artz, absent. Motion Passed.
