# **REGULAR BUSINESS**

A motion by Vince Coia, seconded by Hank Gibson to approve the minutes of the Regular Meeting of August 14, 2018. R/C: Mr. Coia, yes; Mrs. Artz, yes; and Mr. Gibson, yes. Motion Passed.

Vince announced the correspondence book was available for public viewing.

# **TRUSTEES**

The Economic Development Director job description was reviewed. Pat said the minimum number of hours per week needed to be specified.

The son said everything else was covered by the insurance, he did not know why our bill had been missed.

Road Superintendent Ray Taylor reported the following:

The road crew has crack sealed many of the roads in the township and are currently working in the Timber Run Development.

The springs on garage door in bay one broke. We need to have Bob Collins replace them; he quoted \$250.00.

The Four Chaplains veteran monument has been moved back onto its base safely. Ray showed the Trustees pictures of the completed project.

The Grandview Burial Policy reviewed by Chris Meduri has been updated and modified.

# ZONING DEPARTMENT

Zoning Inspector Jim DiPaola reported the following:

The Zoning Commission meeting scheduled for August 29, 2018 has been rescheduled for September 12, 2018 at 7 PM in the Trustees meeting room.

The Haven of Portage is attempting to do their proposed building use in phases, which was not the way the BZA approved the project. We have notified the Building and Health Departments of the situation. One of the problems the project has run into is they were going to tap into a water source that turned out to be privately owned. As a result, there is no source of water for fire protection. There also is no available sewer.

### FIRE DEPARTMENT

Fire Chief Mark Kozak was present reported the following:

We were turned down on the Walmart Grant. Mark is going to re-apply.

Mark would like to send Captain Blubaugh to Basic Origin and Cause class. He needs this class to become a certified Fire Inspector

The full time firefighters should be sending their intent to negotiate soon. Captain Collins will be returning to work on Thursday.

There will be a Multi-Agency Radio Communications System (MARCS) meeting held on September 12, 2018, from 6 PM to 7:30 PM, at the Northeast Ohio Medical University.

We are still waiting on the quote to disable to current heating/air conditioning system.

The new ambulance has been delivered.

Fiscal Officer Gail Pittman joined the meeting at this point.

Lighting District assessments for the tax year 2018, to be collected in 2019 were presented and discussed. It was determined that the assessments would be certified for one year right now.

- WHEREAS the Board of Trustees of Ravenna Township, in a legally convened meeting, voted to create the lighting district called the Forest Ridge Lighting District Phase 3 and 4 and which will consist of forty one (41) lots and thirteen (13) street lamps and,
- WHEREAS the Board of Trustees of Ravenna Township, in a legally convened meeting, voted to create the lighting district called the Pine Ridge Estates District and which will consist of twenty eight (28) lots and eight (8) street lamps and,
- WHEREAS the Board of Trustees of Ravenna Township, in a legally convened meeting, voted to create the lighting district called the PMHA Lighting District and which will consist of twenty eight (1) lots and five (5) street lamps and,
- WHEREAS the Board of Trustees of Ravenna Township, in a legally convened meeting, voted to create the lighting district called the Reserves of Breakneck Creek Lighting District and which will consist of forty five (45) lots and zero (0) street lamps and,
- WHEREAS the cost of this lighting district was to be assessed to the lot owners of record and,
- WHEREAS the electrical power provider, First Energy Corporation, has provided the cost estimate:
  - \$5.00/month/100 Watt light,
- RESOLVED that the yearly cost will be assessed to the lot owner of record as indicated on the Special Assessment form provided by the Portage County Auditor's Office

We received the letter of acceptance from the Ohio BWC into the Group Retrospective Rating Program for the year starting January 1, 2019.

Gail mentioned that Ray had requested the purchase of a new desk. His is falling apart; the drawer keeps falling out and landing on his feet. Gail was thinking of moving Jon's desk up there and getting another one for downstairs. The Trustees said do whatever is necessary to get Ray set up with another desk.

The lock that we had purchased for the mausoleum will not function as we had thought it would. The company said there would be a restocking fee of 25% if we do not purchase another lock from them. The Trustees asked Ray to look into another lock, and if there is not another option, try talking with the company again. If they are not willing to work with us, Jim said he would get involved and, if necessary bring the prosecutor into the conversation.
