Ray submitted the following report:

Ray has updated the City and the County as to their own mutual agreement stating who has roadside mowing responsibilities on Lovers Lane. Ray has mowed it a couple of times when it has become a hazard, but it isn't the Townships responsibility. Hopefully the correct parties will be stepping up and handling it in the future.

Road repairs to the streets around Cotton Corners is nearly complete. Ray will alert H Luli when we are done and they will schedule for the chip and seal project.

Two door springs broke on one the upper bay doors. H.W. Door made repairs.

Romea Roofing has completed the foam roof above the fire station and installed new drains. The will be back to begin work on the interior ceiling at the end of this week and they should spray it this Monday.

Ray is taking the new truck to have the plow installed on Wednesday.
