# RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF DECEMBER 15, 2020

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on December 15, 2020. Trustee Vince Coia called the meeting to order at 7:09 P.M.

Roll call showed the following present: Trustees Hank Gibson, Vince Coia, Pat Artz, Fiscal Officer Gail Pittman, Road Superintendent Ray Taylor, Zoning Inspector Jim DiPaola, and Fire Chief Mark Kozak. Assistant Fiscal Officer Jon Summers was absent.

#### **REGULAR BUSINESS**

A motion by Vince Coia, seconded by Hank Gibson to approve the minutes of the Special Meeting of November 20, 2020. R/C: Mr. Coia, yes; Mrs. Artz, yes; Mr. Gibson, yes. Motion Passed.

The Memorandum of Understanding for the Jack Schafer Trust was reviewed. A copy has been sent to the prosecutor's office for approval.

#### FISCAL OFFICER

BWC has issued the 3<sup>rd</sup> dividend on Dec 14<sup>th</sup>. The check has not been received yet, but it is populated on their website. They have withheld our 2021 estimated premium from the dividend and will be sending us the remainder. The total dividend is \$105,696.70 minus the premium of \$20,082.00 with a net deposit of \$85,614.70. The net amount for each dept is as follows: General \$12,328.81, Road \$15,477.13, Grandview \$1,122.75 and Fire \$56,686.01. A detailed schedule of the calculation is in the trustee meeting folder.

# DEPARTMENTAL REPORTS ROAD DEPARTMENT

Ray was present and submitted the following report:

The lettering on the 2014 F150 pickup truck and the Office Door is done.

Kayline has quoted \$158.80/ea. for the touchless paper towel dispensers. We would need eleven of them at a total cost of \$1,746.80.

Famous Supply has quoted an estimate of \$17,306.41 for the touchless fixtures for the entire building. The quote for labor from the plumber has not been received.

Ray requested an executive session at the end of the meeting for employee compensation purposes.

#### **GRANDVIEW CEMETERY**

There were nine burials and two cremations in the past two weeks. Ray expects the increase in burials to continue.

#### **ZONING DEPARTMENT**

Zoning Inspector Jim DiPaola was present and submitted the following report:

Jim received a call that the intersection of Hayes Road and SR 14 is dark. The caller stated that the street light was left on the pole where Hayes Rd used to come out on SR 14. The caller says he spoke to ODOT and was told it is the Township's responsibility to move it.

We are still waiting for the demolition of 6782 Garfield to begin.

Online Motor Credit located at 2753 SR 59 has closed and the property is for sale, list price is \$250,000.

#### **LIAISON**

Jim has been sending the architect services specifications to those people requesting them.

We have received a quote from Productive Inc. of \$2,797.00 for cleaning the air ducts in the building. We also need to have Kozma Electric install 1 outlet for a monitor and change two outlets from the 2 plug outlets to 4 plug outlets in the front entrance.

A motion by Vince Coia, seconded by Hank Gibson to approve the air duct cleaning by Productive Inc at the quoted price of \$2,979.00 and to have Kozma Electric install needed outlets in the front entrance of the Administration office using BWC funds from the General account. #### **FIRE DEPARTMENT**

Fire Chief Mark Kozak was present and submitted the following report:

The state is not reimbursing us on the FEMA Public Assistance Reimbursement Program as they had originally promised. Mark is waiting on more info from the state in regards to this and requested authorization to apply for a second FEMA PA Grant if necessary. We may need to send

the unused portion back to them, then apply for the second grant to get it back from them. Ohio EMA administers this grant and we are still awaiting guidance from them on how to proceed.

A motion by Hank Gibson, seconded by Vince Coia to authorize Chief Kozak to apply for an additional FEMA PAG if it becomes available. R/C: Vince Coia, yes; Pat Artz, yes; Hank Gibson, yes. Motion passed.

Firefighter Smith has requested a leave of absence.

Mark requested an executive session at the end of the meeting to discuss a disciplinary action issue and compensations.

The new utility truck should be in service next week after the lights and sirens have been installed.

Another washer is needed for increased gear washing being done due to COVID-19. It can be purchased using CARES funding.

The old 2005 Ford Explorer has sold on GovDeals for \$1,800.00

## NEW BUSINESS TRUSTEES

The UAN program is denying the leave accruals on the next payroll run because of the extra 27<sup>th</sup> pay cycle in the 2020 year. Our CBA's and policy handbook state that the sick and vacation pay are on an annual basis and the UAN system should not allow additional accruals for those who have hit their total for the year.

A motion by Vince Coia, seconded by Pat Artz to deny over-riding the UAN system due to the accrual limits are set for an annual basis. Devin Shipp and Brad Hager are the only full time employees who have not hit that limit and their accruals will be granted on the last payroll run. NOPEC is allowing another \$1,500 award for the township to use in the 2021 year. The Trustees will discuss the usage early in the next year.
