The city has offered to have a new road off Summit Road be constructed instead of a private drive. The railroad representative indicating that he may be able to get the railroad to cover the construction expense if it is an actual road instead of a private drive. The city would then maintain the road.

We are still waiting on the budget bill to pass to finish the FEMA Public Assistance Reimbursement Program filing.

The FY2020 AFG grant has been submitted.

The Fire House Subs Grant has also been submitted.

Firefighter Bryant has requested a 6 month Leave of Absence.
