## RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF JULY 27, 2021

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on July 27, 2021. Trustee Hank Gibson called the meeting to order at 7:04 P.M.

Roll call showed the following present: Trustees Vince Coia, Pat Artz and Hank Gibson; Fiscal Officer Gail Pittman; Fire Chief Mark Kozak, Zoning Inspector Jim DiPaola and Assistant Fiscal Officer Jon Summers. Road Superintendent Ray Taylor was absent. There were many residents from the Fairhill/Hodgson neighborhood.

## **AUDIENCE**

Michael Canan spoke about water problems in his basement when it rains. It is not a new problem and the situation was much better when they used to have open ditches.

Greg Karasek was not a resident there but was speaking for his mother-in-law. He made a map of work that has been done in the neighborhood since 1993 and discussed what he has documented. Many people have had to put in B-Dry systems in their basements.

Sandra Alger moved to her Hodgson address in 1989 and is down lower from the cemetery. She believes that every time a grave is dug and a cement vault is placed, it makes the flooding in her yard worse. Professionals (one from Soil and Water) have told her that is not the case.

Tim Craft said Rhinehart talked to a neighbor and put in a swale. He said the yards didn't start flooding until Rhinehart had cut in the hill in the back part of the cemetery.

Matthew. Clites spoke about the improvements in their yards as a result of their mitigation efforts. He put a large pipe that is not tied into the culvert because the culvert doesn't work. He believes that when the culverts used to work, they were probably tied into a retention pond. He inquired as to where Ray would start looking with a camera.

Kim said one of the catch basins is higher than the surrounding pavement.

Tim said that Ray did come out and look at the pipes a couple of years ago. There was a collapse and they fixed it, but the problem is back again, so the problem must exist in a different place.

Another resident complained that back in 2003 water was coming in from Summit Road and the County said there was nothing they could do about it.

Vince spoke how in the past, in areas that were flooding, we were able to borrow the City's sewer jet camera. He said we possibly might be able to do that again and will get Ray out to inspect.

Vince and Hank both stated that we may be able to use the ARPA funds to mitigate the problem. Mark Kozak told the group that this type of problem needs to connect with EMA to get this issue on their radar. Randi Clites said she contacted them already and they said this does not qualify because they see it as a backup issue, not a flooding issue. Many residents shared pictures and videos of their problems. Vince Labbe volunteered to be the contact for the group for future communications.

Gail gave an update on the new building. CTMS has installed the new Fiscal Officer PC as provided by UAN and now appears to be working fine. The old PC is no longer in service and the State Auditor has donated it to the township. It will be cleared and will be used in the new building.

## **ROAD DEPARTMENT**

Ray was absent and Vince reported the following:

The contractor repairs to Hidden Brook have been completed and the new paving will begin tomorrow (Wednesday).

Lang Automotive has completed the frontend work on one of the road trucks The curb repairs on Pineridge are done.

#### **GRANDVIEW CEMETERY**

Two spots in the Columbariums have been sold. Someone is interested in purchasing a 12 plot area in one of the cemetery sections.

Pat inquired as to whether any of the Covid money could be used to put in a bathroom in the building out on Cleveland Road. Gail said the sewer lines there were capped years ago.

#### ZONING DEPARTMENT

Zoning Inspector Jim DiPaola was present and reported the following:

The BZA met July 14, 2021 to hear a variance request from William Hopkins, 4964 Woodview Rd. to build an accessory building in the front yard area of his property. The variance request was denied.

A violation letter was sent to the owner of 6148 Spring St. The property owner contacted the Zoning Inspector on July 27, 2021. The chickens and most of the junk and trash has been removed and the owner has been given until August 6, 2021 to complete the clean-up.

A violation letter was sent to 3392 SR 59. The owner contacted the Zoning Inspector on July 27, 2021 to state the tenant had been put on notice and the full dumpster is to be picked up by Friday, July 30, 2021. The owner was given until August 6, 2021 to correct all violations.

The property owner at 6437 Woodlawn called to complain about a street light that is located on her property that shines on the yard and not the road. Jim investigated and found that the street light does shine on the yard and not the road. There is another street light approximately 50 feet away that does light up the intersection of Woodlawn and Plainview. The street light in the yard is being paid for by Ravenna Township. Jim requested a motion to have the street light disconnected and removed from the pole by First Energy. A discussion ensued about how and when a yard light would have been put in by the township. The Trustees asked Jim to find out the expense of removing the streetlight.

#### LIAISON

The Building Committee met on July 21, 2021 and reviewed the new building specifications.

## FIRE DEPARTMENT

Fire Chief Mark Kozak was present and reported the following:

The items to be purchased from the FEMA Public Assistance Program have been ordered.

The Ohio EMS Reimbursement Grant items have also been ordered.

The FEMA AFG 2018 and 2019 Grants are waiting to be closed out.

Mark has reapplied for the Firehouse Subs Grant.

Firefighter Patton is requesting a leave of absence until January 27, 2022.
