RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF DECEMBER 14, 2021

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on December 14, 2021. Trustee Hank Gibson called the meeting to order at 7:09 P.M.

ROAD DEPARTMENT

Ray was present and reported the following:

We've replaced the 3 pieces of 8" pipe to the City of Ravenna that we borrowed from them to make repairs on Spring St at SR59.

Ray discussed the storm damage that occurred over the weekend. It wasn't bad, just a few trees down and a couple of flooded roads. He thanked the Fire Department for placing road closed signs out on Bridge St for him. The Road Crew was picking up the remaining bags of leaves and brush.

The Road Crew is doing equipment maintenance in their slow time.

GRANDVIEW CEMETERY

There were three burials and one cremation in the last two weeks.

Ray saw Mrs. Clites in the cemetery after the storm picking branches and placing them nicely in neat piles. He thanked her for her thoughtfulness.

ZONING DEPARTMENT

Zoning Inspector Jim DiPaola was present and reported the following:

The Zoning Board of Appeals met Wednesday, December 8, 2021 and granted variances to both requests: Hasna Nouri, 3090 Summit Rd, to create lots smaller than 1.5 acres and to Dollar General on Cleveland Road to allow a higher sign than allowed by code.

Jim is working with Gail to review applicants for both Zoning Inspector and the Zoning Secretary.

Ruth Schell, who has served for a long while on the Zoning Commission, has passed away. Jim wanted to acknowledge all of the good work she has done. The Trustees agreed and asked that a card be sent to the family.

Jim requested to attend the Ohio Township Association 2022 Winter Conference on January 26-28, 2022 in Columbus. He will be able to get his required Sunshine Law class completed while he is there. Hank said he was also thinking about going to that conference.

We received the \$5,000 Walmart grant money. Mark will use it for battery powered saws in 2022.

Mark requested that the township purchase an extra chain saw kit with the grant money at the beginning of next year.

Mark continues working with Matt and Jim on the Fee Schedule for fire code review for new construction plans.
