RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF DECEMBER 28, 2021

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on December 28, 2021. Trustee Hank Gibson called the meeting to order at 7:09 P.M.

Roll call showed the following present: Trustees Vince Coia and Hank Gibson; Fiscal Officer Gail Pittman, Zoning Inspector Jim DiPaola, Fire Chief Mark Kozak (via Microsoft Teams), Road Superintendent Ray Taylor and Assistant Fiscal Officer Jon Summers. Trustee Pat Artz was absent. In the audience was Michelle McCoy and many friends and relatives of Jim DiPaola.

Gail swore in both Jim DiPaola and Vince Coia for their 4 year terms as Ravenna Township Trustees commencing January 1, 2022.
