## RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF EMERGENCY MEETING OF JUNE 29, 2022

The Ravenna Township Board of Trustees met in Emergency Session at the Ravenna Township Trustee's Meeting Room, 6145 Spring Street, Ravenna, Ohio, on June 29, 2022. Trustee Vince Coia called the meeting to order at 12:32 P.M.
