The chains for the little plow tractor have been installed.

The new plow blades for the trucks have been installed and the trucks are ready for the snow.

Ray is still working with O'Brian Sewer Jet to see if a camera is available for the unit that Ray has chosen.

Maintenance prepping for the winter weather is being done.

The camera on Hopkinson Ave has been removed for the winter.

Ray has been checking on prices of storage building. He estimates we would need a 50'X 80' one to hold all the stuff that is in the building on Cleveland Rd.

The new roadside mower is torn apart and waiting on parts.

### **ZONING DEPARTMENT**

Melissa was present and reported the following:

An application from Haaz Automall was received for an 8,400 square foot commercial structure on Hazel St.

Melissa has been organizing all the zoning records in preparation for a new zoning inspector. She has been creating procedures regarding the application process, filing, server organization, hearings, etc.

The BZA will meet Wednesday, December 14, 2022 at 6:00 pm to review and approve minutes from the November 9, 2022 public hearing. There are no applications before the Board this month.

The Zoning Commission is scheduled to meet on January 18, 2023 to approve the minutes from the November 16, 2022 meeting and to discuss several proposed changes to the code book.

Melissa and Jim are going through the resumes of applicants for the zoning inspector position. They have received 27 applications, about 10 of them look interesting.
