Only one of the trucks actually requires a CDL to drive it. He presented an analysis of the pay rates from the other townships in the county. Hank said he was opposed to providing schooling for jobs, but would be open to discuss raising the rates.

Ray presented two additional quotes on the new storage building. Jim said he would take the next step of contacting the attorney to get the bid documents written up properly.

Ray said he is ready to work with Mark on getting the old roadside mower placed for sale on GovDeals.com.
