## RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF JULY 11, 2023

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6145 Spring Street, Ravenna, Ohio, on July 11, 2023. Trustee Hank Gibson called the meeting to order at 7:00 P.M.

Roll call showed the following present: Trustees Vince Coia, Jim DiPaola and Hank Gibson, Fiscal Officer Gail Pittman, Fire Chief Dave Moore, Fire Liaison Mark Kozak, Zoning Inspector Lori Rotondo, Road Superintendent Ray Taylor, and Assistant Fiscal Officer Jon Summers. In the audience were Frank Hairston, Randi Clites, Mr. and Mrs. Donald Nelson, Ryan Bisari, and Amelia Wolf.

#### **AUDIENCE**

Frank Hairston spoke with Dan Morgani about demolition of properties in the McElrath and Skeels developments. Frank brought Mr. and Mrs. Nelson to the meeting because they have properties in McElrath that would qualify for land bank consideration.

Donald Nelson said he has a vacant house at 6640 Sumner St. that he had boarded up. Someone has come in and stripped all the wiring and plumbing from the building. It is no longer livable and he would like to know how he can go about getting it demolished. Jim said the property has to be condemned by the Fire Department, the Health Department, and the Building Department. Once they all sign off on that, the request would go to Mr. Morgani for consideration of demolition.

Frank said he has a meeting set for Thursday at 10 am with the County Prosecutor to discuss renaming the street discussed at the last meeting. He also said the bids for the King Kennedy project are going out soon.

Randi Clites, from the Board of Elections, spoke about the upcoming Special Election on August 8, 2023. She said they are looking for volunteers to work as poll workers as there are a shortage right now. They will be paid \$20 for a training class and then paid \$130 the day of the election.

## ROAD DEPARTMENT

Ray was present and reported the following:

The work on Winding Creek Dr. is about 90% complete. Once that is finished the road crew will focus on Marian Rd and Edwards Rd in preparation for the upcoming paving project.

Roadside mowing is being done.

Ray said he needed to purchase new blades for the chipper from Vermeer Sales. It should be under \$300.00.

Ray will be working with Melissa to write for the \$2,500 Cemetery Grant. Gail said Frank Cimino forwarded the cemetery grant opportunity information to her through Chad Murdock; although we already were in the process of reviewing it to apply.

Fire Chief Dave Moore was present and reported the following:

The Fire Dept has been very busy today, including a grass fire up on Lake Rockwell Rd.

Several members of the department would like to join the special teams in the county – Firefighter Cook would like to join the USAR, Firefighters Adams and Heffley would like to join the Dive team where the Chief already participates.

The Chief requested to purchase several different things.

Chief Moore recommended contracting with Turnouts for advanced cleaning, inspections and repairs of turnout gear.
