RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF AUGUST 6, 2024

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6145 Spring Street, Ravenna, Ohio, on August 6, 2024. Trustee Jim DiPaola called the meeting to order at 7:10 P.M.

Roll call showed the following present: Trustees Vince Coia, Jim DiPaola and Hank Gibson, Fiscal Officer Gail Pittman, Road Superintendent Ray Taylor, and Assistant Fiscal Officer Jon Summers. Fire Chief Dave Moore and Zoning Inspector Lori Rotondo were both absent and Captain Sweitzer filled in for Chief Moore. In the audience was John Blankenship.

REGULAR BUSINESS

Jim said the first step would be for the township to get an appraisal on the lot and then put the lot out for bid. The trustees said they would let him know when all that is accomplished and when the bid advertising is placed.

The trustees have been notified by Regional Planning of the combination of parcels by James Sanders for the purpose of building a duplex.

Jim spoke with the director at the county sewer department about the recent water bill. The director said he will do what he can.

Matt Kelly would like to determine what days would be good for him to use the meeting room to have a town hall meeting with the residents regarding the upcoming changes in property values. He is planning to have these meetings all over the county.

Jim said he would get hold of Dennis West to have him come in for the 3rd quarter Economic Development meeting.

Vince said he attended a meeting with the residents of the Chinn Development regarding the sewer project. Sherrod Brown has provided literature about sewer project funding and Pavliga also provided an informational flyer.

FISCAL OFFICER

Jim Zuccaro from Summit Insurance doesn't have the new policy completed yet, but expects to have it done for the next meeting on the 20th.

Gail heard from the attorney regarding the TIF agreement for the Forest Ridge Development. It is not done yet, but should also be done for the next meeting.

ROAD DEPARTMENT

Ray was present and reported the following:

The chip and sealing part of the project has been completed. Parts of Creekview need to be redone. They will be brooming and striping next. Ray said the inspector did an excellent job and he will keep the contact information for future jobs.

The Road Crew is still working on repairs in the Chinn Development.

Octane Night is tomorrow afternoon and Ray will be taking up Con barrels to help with traffic control.

One of the bay doors needs repaired. Ray has contacted H&W Doors to come fix it.

GRANDVIEW CEMETERY

There were two burials and one niche sale in the past two weeks.

Layin It Down Concrete has all the forms ready to pour the concrete. They should be out to do that tomorrow or Thursday.

The grant for the cemetery chairs has been submitted.

ZONING DEPARTMENT

Lori was wondering if it was ok to dismiss the case for 3719 Lovers Lane, they are 90% cleaned up. The trustees said no, not until the cleanup is complete.

They wrote a response letter stating that they don't have the financial means to fix and move their RV, so they may have to purchase another RV and park it somewhere else. She said hopefully they will get it all figured out at the next court hearing on August 28, 2024.
