**RESOLVED**, that pursuant to R.C. 517.23(D) the Board will cause notice to be immediately sent to any declared person or persons with the rights of disposition to the deceased person, or if no declaration was made pursuant to R.C. 2108.70 to 2108.73, then notice shall be sent to the highest priority individual available pursuant to R.C. 2108.81.

The Chief's truck, 2400, also needs preventative maintenance. The heart monitors have both been recalled for BP/Pulse Ox issues. The department is now taking all vitals manually.

A request for two purchase orders was made, one for Graphic Expressions for Township stickers on new ambulance, one for new tire for the UTV. The amount for Graphic Expressions is unknown and so is the vendor and amount for the tire for the UTV. Purchase orders will be placed on the books when that information is received
