RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF JULY 2, 2019

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on July 2, 2019. Trustee Hank Gibson called the meeting to order at 7:00 P.M.

Roll call showed the following present: Trustees Vince Coia, Hank Gibson, Fiscal Officer Gail Pittman, Fire Chief Mark Kozak, Zoning Inspector Jim DiPaola, Road Superintendent Ray Taylor and Assistant Fiscal Officer Jon Summers. In the audience were Beth Straubhaar and Dale Todd. Trustee Pat Artz was absent.

AUDIENCE

Beth Straubhaar said her great-grandmother was buried at Maple Grove Cemetery and her marker has been destroyed by the mower. She was wondering the proper procedure for getting it replaced. Hank told her that he was on the Maple Grove Board and referred her to speak with Mark Gabriel at Maple Grove. Hank will follow up with Mark.

Mr. Todd asked about paving Hidden Brook. He was disappointed upon reading the past minutes to hear that the paving wasn't going to be done soon. The Trustees told him that the current budget wouldn't allow paving of that road yet. Ray told him that he would be maintaining the road as best he can, but the repaving would not be happening for a while. Gail told him the Hidden Brook repaving project is budgeted to be done in 2022.

Hank announced the correspondence book was present and available for public viewing. A motion by Hank Gibson, seconded by Vince Coia to approve payroll warrants for July 5, 2019 in the amount of \$50,574.93 and other warrants in the amount of \$13,028.20 with warrants over \$1,000.00 being read aloud for approval. FISCAL OFFICER

Jon's printer has been replaced. The old printer needs disposed of.

The dental insurance renewal for 2020 has been received. There is no increase in cost or decrease in benefit.

Gail presented the OTARMA insurance appraisal report of tangible property assets. She said the main building value has gone down by a million dollars. The Trustees asked Gail to have the insurance agent come to the next scheduled meeting to discuss the changes.

The state has approved the new flag pole fund. Fund #2902 has been added.

The quotes for computer upgrades/replacements have been received. The new server will be \$7,719. Estimates on new Chrome Books are \$279 each plus install. To upgrade the 7 old desktops with memory and new operating systems would be \$3,100 or replacement cost of 7 new computers would be about \$7,000.

The cemetery grant application guidelines were received, the maximum award per year is \$1,000 for projects. This money cannot be used for regular operating costs. The deadline for application is August 15th.

DEPARTMENTAL REPORTS ROAD DEPARTMENT

Repairs are being made in the McElrath Development in preparation for the chip and seal.

The road side mower is repaired and out mowing now.

Road patching is being done in multiple areas of the township.

The brush chipping is being done as soon as the road crew can get to it. With all the storm damage this season, the normal 1-2 loads every other week has become 6-7 loads.

A small marble door at the mausoleum was damaged during an interment this past Saturday. Ray will get a quote from Portage Marble to replace it.
