REGULAR BUSINESS

A motion by Vince Coia, seconded by Pat Artz to approve the minutes of the Regular Meeting of July 16, 2019. R/C: Mr. Coia, yes; Mrs. Artz, yes; Mr. Gibson, yes. Motion Passed.

Hank announced the correspondence book was present and available for public viewing.

We need to order hydraulic fluid from Advanced Auto. A 50-gallon drum will cost \$267. Gail said there is a PO available.

The chipper was down temporarily. Ray had to order a new radiator at a cost of \$566 through Vermeer Sales.

Ray requested to buy 3 pallets of crack seal from DJL Material for \$3,705.75. That cost includes the use of their crack seal machine. Gail said there is already a PO for \$3,800.00 on the books.
